

DECLARATION

Govt of Assam vide letter no. AHE.04/2017/28 Dated Dispur, the 27th February, 2017 directed to start Vocational Course in B N College, Dhubri. Subsequently, the Department of Higher Education, Govt. of Assam issued a Guideline for introduction of vocational course vide letter no. PC/HE/Misc/17/2016/57 dated Kahilipara, the 28th March/2017, wherein the college has been suggested to opt for B.Voc. course and intimate the affiliating university in this regard. Accordingly, the college sought permission from Gauhati University (affiliating university) to start the B. Voc. undergraduate programme in Information Technology (College letter No. B.N.C/2017/69 dated 17/04/2017). Finally, the Director of Higher Education, Govt. of Assam has issued a sanction letter vide letter no. PC/HE/Misc/79/2016/71 dated Kahilipara 24th April/2017 and the affiliation was granted by Gauhati University to introduce the B. Voc. course in Information Technology.

The amount may be drawn by the Director of Higher Education, Assam for disbursement of the same to the appropriate authorities observing all the existing requisite formalities and subject to submission of Utilization Certificate in due course of time.

The Director of Higher Education is to introduce these subject in the concerned colleges of Assam in co-ordination with Director of Employment & Craftsmen Training (DELT) as Curriculum/ Core standards etc. are being set for such courses through National Council for Vocational Training (NCVT) etc. Further, all the money being proposed seems to be going for civil works, pay etc. though perhaps the course can be started even in many cases using existing facilities.

The expenditure is debitable under the Head of A/c "2202-General Education (Higher Education)-II-Other State Plan & Non-plan Scheme-03-University and Higher Education-104-Assistance to Non-Govt. Colleges & Institutions-0601-Grants to non-Govt. Professional Colleges-125- Financial Assistance Colleges for introduction of courses (Normal) -32-Grants-in-aid General (Non Salary)-99- Other (Plan)" voted during the year 2016-2017"

The sanction is issued as per P & D Department's approval vide U/o No.PDP-152/2017 dated 16/02/2017.



GUIDELINE FOR INTRODUCTION OF VOCATIONAL COURSE IN COLLEGES

The Govt has provided fund for introduction of Vocational Course in 5 Colleges during 2016-17.

Theme : Vocational Course can provide the employment opportunity.

Aim : To enable students to have self employment.

Objective : In the present market of employment vocational courses has a vital role to meet the demand of employment.

Scheme : Vocational Courses have various trades like Information & Technology, Folk & Performing Arts, Travel & Tourism Management, Accounting & Taxation, Retail Management & Information Technology, Soft Ware Development etc. The Colleges/Students can opt any of the above trades under vocational Certificate/Diploma courses as per local/present demand of the employment market.

Financial Assistance for the Scheme : During the financial year 2016-17, Govt. has selected 5 Colleges @ Rs. 20.00 lakhs to each to introduce the scheme in the 1st phase. The schematic break-up of the scheme against the 5 Colleges are shown below :

4. One subject expert to be nominated by concerned University.


As far as possible the colleges will opt for B.VOC Courses of 2 years duration. For this they shall immediately intimate the affiliating University.


In no case the amount received under this scheme will be utilized to augment or supplement any existing course run under assistance of UGC.


